

WHEREAS, the County Board of Fayette County has adopted a resolution establishing the salary of the County Engineer to be 100% of the recommended salary for the County Engineer as determined annually by the Illinois Department of Transportation, and

WHEREAS, the County Board of Fayette County has entered into an agreement with the Illinois Department of Transportation for transfer of Federal Surface Transportation Program funds to pay one-half of the salary paid to the County Engineer.

NOW, THEREFORE, BE IT RESOLVED, by the Fayette County Board that there is hereby appropriated the sum of One Hundred Eight Thousand Two Hundred and no/100 Dollars (\$108,200.00) from the County's

Motor Fuel Tax funds for the purpose of paying the County Engineer's salary from 05/01/21 to 04/30/22 and, beginning date ending date

BE IT FURTHER RESOLVED, that the Fayette County Board hereby authorizes the Department of Transportation, State of Illinois to transfer Fifty Four Thousand One Hundred and no/100 Dollars (\$54,100.00) of Federal Surface Transportation Program funds allocated to Fayette County to the Department of Transportation in return for an equal amount of State funds; and

BE IT FURTHER RESOLVED, by the Fayette County Board that there is hereby appropriated the sum of One Thousand Eight Hundred and no/100 Dollars (\$1,800.00) from the County's

Motor Fuel Tax funds for the purpose of paying the County Engineer's expenses from 05/01/21 to 04/30/22 beginning date ending date
